

## Survey Results

NOTE: This survey was conducted between January 20, 2020 and February 7, 2020, before mass media coverage of the COVID-19 pandemic, the drop in the stock market and massive applications for unemployment insurance.

#### **Overview**

The Minnesota Automobile Dealers Association retained Rapp Strategies and Morris Leatherman to conduct a scientific survey of 800 Minnesotans to understand opinions about Governor Walz's proposal to adopt the California vehicle emissions standards through administrative action.

Only 5% of Minnesotans say they are very likely to consider an electric vehicle when they make their next purchase, citing concerns about higher cost, performance in the cold and a lack of charging stations.

Electric vehicles are significantly more expensive than similar gas-powered versions. Since their introduction in the market, electric vehicles have never exceeded 1.5% of all vehicle sales in the state.

Gov. Tim Walz has recommended that Minnesota adopt California vehicle emissions standards by administrative action. This action would occur without legislative review. If approved, the price of all new vehicles sold in Minnesota will increase by a minimum of \$800, according to the Minnesota Pollution Control Agency.

The California restrictions would also mean that some trucks, SUVs and vans will not be available for Minnesota drivers because auto dealers would be required to maintain higher inventory levels of electric vehicles and other lower-demand automobiles.

**Methodology**: The survey was administered to 800 randomly selected adult residents in Minnesota by Morris Leatherman Company. Professional interviewers conducted the survey via landline and cell phone calls between January 20 and February 7, 2020. The typical respondents took twenty-four minutes to complete the questionnaire. Cellphone only households with 42% of the sample, landline only households with 10% of the sample; with the remaining 48% having both cellphones and landlines. The results are projectable to all adult residents in Minnesota to within ±3.5% in 95 out of 100 cases.

#### 1. Interest in electric vehicles in Minnesota remains low.

### 1(a). Those open to electric cars are concerned about higher cost and performance.

Thirty-one percent of respondents stated they were either "very likely to include electric vehicles" among their choices for their next car or "thinking about electric vehicles." We asked them:

Support for the Walz plan to adopt the California car standards as quickly as possible was no higher than 13% among any income group, and a majority of people who make less than \$75,000/year believe the legislature needs to study the standards and vote on them before they are adopted.
